- 1. The Government of India, Ministry of Water Resources, River Development and Ganga Rejuvenation has received financing from the World Bank toward the cost of the National Ganga River Basin Authority, and intends to apply part of the proceeds for consulting services.
- 2. The consulting services (the Services) include the conceptualization and production of an Information Campaign around the infrastructure and facilities developed for the Riverfront Development Project in Patna being executed by the Bihar Urban Infrastructure Development Corporation (BUIDCO). The Communications Campaign is aimed at (i) informing citizens about the riverfront infrastructure being developed at the ghats along the river Ganga in Patna, (ii) enhancing people's use of the upgraded facilities, (iii) improving people's access to these facilities through appropriate signage that focuses on safety and crowd-movement; and (iv) creating a distinct brand identity for the riverfront.
- 3. The assignment will involve the conceptualization of a mass communication campaign and the development and production of relevant creative and signage material. It is envisaged that the campaign could cover, but not be limited to, communication channels such as street hoardings; radio spots; printed communication collaterals such as information brochures/ handouts etc; site signage; branding material; etc. It will also cover the conceptualization and organization, in collaboration with BUIDCO, of direct outreach events such as ghat festivals etc. aimed at increasing people's use of these riverfront facilities.
- 4. BUIDCO now invites eligible consulting firms (Consultants) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. Consulting firms should have prepared similar mass communication campaigns.
- 5. The short listing criteria are as follows:
 - a. Experience of the firm:
 - i. Core Business Area, Organization and number of years of relevant experience
 - ii. Must have successfully completed at least three assignments of similar nature in last ten years (Letter of Award from employer/ Project Completion Certificate is to be submitted)
 - b. Financial Soundness, turnover and profitability:
 - c. Turn over figure for last three years
 - i. Net Profit figure for last three years.
- 6.
