- 14. Bidding will be carried out under single stage two envelope (technical and price bid) system. Consultants will be evaluated under Least Basis Selection.
- 15. Eligibility Criteria for participating consultants:
 - i. Consultancy Firm (s) should have been in operation in India for at least 5 years.
 - ii. Minimum annual turnover of the consultancy firm (s) should have 10 crore in any financial year out of 7 years.
 - iii. The Consultancy Firm should have prepared DPR of at least three towns for each sector projects i.e; (Sewerage, Drainage) in last 10 years. Each sector three town DPR cost should not be less than 100 crore (combine cost). The consultant should submit work completion certificate along with the proposal in respect of such experiences.
 - iv. The Consultancy Firm should have experience of project supervision and quality control of at least three projects in each sector i.e, storm water drainage and sewerage in last 10 years.

16. The Consultancy Firm should have experience in providing Technical Support for Procurement of Goods and services, contract management.
