- 1. The invitation for Bid follows the General Procurement Notice for this Project that appeared in UNDB online on 30.03.2011 & updated last on 31.01.2014
- 2. The National Ganga River Basin Authority (NGRBA), Ministry of Water Resources, River Development & Ganga Rejuvenation, Government of India has received financing of US\$ 1 billion from the World Bank towards the cost of the National Ganga River Basin Project and intends to apply a part of the proceeds towards payments under the contract for work detailed below.
- 3. The NMCG, State Governments of Uttarakhand, Uttar Pradesh, Bihar, Jharkhand and West Bengaland the ULB have entered into a Memorandum of Agreement for implementation of the NGRBA programme in the respective states.
- 4. The State Government of GOB and Government of India have entered into a Memorandum of Understanding towards the implementation of this project forming a part of the NGRBA Programme.
- Qualification requirements as listed briefly below are required to be fulfilled by the bidder. [Bidders are advised to refer to the bidding documents for complete details]

Financial:

- a) The Bidder shall demonstrate that it possesses a net worth equivalent to minimum of INR 530 Million as average of the last three financial years preceding the date of submission of bid.
- b) The Bidder shall demonstrate through a banker's certificate that it has available cash credit facility equivalent to minimum INR 278 Million as on the date of submission of bid.

Technical:

- 1. The Bidder shall provide evidence that it has Designed, developed, built, tested and commissioned at least 1 STP of 18MLD or 2 STP of 13MLD or 3 STP of 9 MLD during last 7 years preceding the month of publication of NIT.
- 2. The bidder or his nominated sub-contractor has successfully commissioned at least one Sewage Treatment Plant with the same technology as proposed for this contract for the lowest STP capacity mentioned in clause 1.4 (a) 1. above,

- operating successfully for a period of 1 year during the last 7 years preceding the month of publication of NIT. *In case of special treatments, tertiary treatment etc.* The Qualification Criteria maybe suitably modified on case to case basis
- 3. The Bidder has the experience in operating and maintaining successfully at least 1 STP of 18MLD or 2 STP of 13MLD or 3 STP of 9 MLD STP during 1 year over the last 7 years preceding the month of publication of NIT.
- 4. The treatment technology proposed for this contract has been adopted (not necessarily built by the bidder) in at least 3 locations during last 7 years preceding the month of publication of NIT and that such STP has been operating successfully (meeting the required performance standards and environmental norms specified in the Contract) for a period of minimum 2 years over a period of last 7 years preceding the month of publication of NIT.
- 5. It has designed, developed, built, tested and commissioned Sewerage Network of 111 KM length of the total scope of sewerage network collectively from maximum 3 projects during the last 7 years preceding the month of publication of NIT; of which 50 % should be above the pipe diameter (1000mm)
- 6. It has designed, developed, built, tested and commissioned pumping stations having minimum capacity not less than 19 MLD collectively from maximum 3 projects during the during last 7 years.(i.e. 11-12 to 2017-18).
- 7. The bidder or his nominated sub-contractor has operated and maintained Sewerage Network of 111 KM length of the total scope of sewerage network collectively from maximum 3 projects during 1 year over the last 7 years preceding the month of publication of NIT
- 8. The bidder or his nominated sub-contractor should have successfully operated and maintained sewerage pumping stations for capacity not less than 19 MLD collectively from maximum 3 projects for period of 1 year during last 7 years.
- 9. The bidder or his nominated sub-contractor has designed, built and commissioned Sewerage Network using trenchless technology for a minimum of 1.25 KM of the proposed length of the network to be laid using trenchless technology, during the last 7 years preceding the month of publication of NIT.
