- 15. Eligibility Criteria for participating consultants for each group;
  - I. Consultancy Firm (s) should have been in operation in India for at least 5 years.
  - II. Minimum annual turnover of the consultancy firm (s) should have 10 crore in any financial year out of 7 years.
  - III. The Consultancy Firm should have experience of construction supervision and quality control of at least one project comprising of storm water drainage network, Pumping Station in last 10 years. (For Group 1,2)
  - IV. The Consultancy Firm should have experience of construction supervision and quality control of at least one project comprising of storm water drainage network or Pumping Stations and Sewage Treatment Plant on SBR Process in last 10 years. (For Group 3&4)
