 - b. Concept design- lay out plan, floor plans, views etc sufficient to explain the design including brief specification.
 - c. Brief report and PAR estimates based CPWD norms with indexing.

 - 4.1.4 Envelop "A", 'B' and 'C' shall be submitted together in a sealed envelope marked with name of project and name of firm on top of the envelop.
 - 4.1.5 Duly completed and signed offer should be submitted as per published notice.
- 5. Eligibility Criteria for participating Consultants:
 - (i) Architects/ Architectural Firm (s) should have been incorporated and operational in India for at least 10 years of professional experience as on 31st March 2018.
 - (ii) Average annual turnover of the Consultancy Firm (s) Minimum Annual turnover from professional fees in any one year of last three years should be Rs.1 Cr.
 - (iii) Should have provided comprehensive architectural services for completed govt./ semi govt. Building project of not less than two projects of Rs 30 Cr. each or three projects of Rs- 20 Cr. each.
- (6) Interested Consultants may submit their proposals along with (i) Bid Document Cost of INR 10000.00 (Non-refundable) and (ii) Bid security of INR 1.5 Lac (Refundable) as per provision of RFP Document on or before the Due Date of **27.06.2019** till 3:00 PM.
