1. Quotationer must visit the Park before filling quotation.
2. Quantities mentioned in the Financial Progress may decrease/increase.
3. In case of successful Quotation, the amount of the earnest money will be transferred to the initial security deposit (Performance Guarantee) and balance amount will be deposited by the contractor to cover up five percent (5%) security deposit before execution of the agreement and further five (5%) security deposit (Performance Guarantee) will be deducted from each running bill.
4. Conditional Quotation shall be outright rejected.
5. In the event of the Quotation being submitted by a firm in must be signed by each member or by a person holding the power of attorney authorizing him to do so. The partnership deed of the firm should be enclosed in the Quotation lacking which the quotation will be rejected.
6. Before using the material in work, samples of material are got to be approved from BUIDCo.
7. Contract duration for printing ticket is Two year. Further which may extended based upon scarification performance.
8. The department reserves the right to decrease the quantity. Payment will be made on the basis of actual supply of page of ticket as per agreement rate.  
Any omission or error arising out of the slip of typing mistake or clerical error in specification, labguage, quantity and rate in the quantities shall not have adverse effect.
9. The delivery of the entry tickets shall be as per the order given by BUIDCo. The delivery shall be made on the same date of its order and the selected agency should deliver the ticket even in the holidays.
10. The sample of the tickets are attached with the herewith.
11. Justification of cost sheet be located in patna city (if any disputed areas).
12. Any disputes arising out of this NIT/Bid documents. The same shall be referred to MD, BUIDCo for his decision and decision of MD, BUIDCo shall be final and binding upon both the parties to the contract. However in case of dissatisfaction either party shall move before Bihar public works contracts disputes arbitration tribunal situated at Patna and the provisions of Bihar Public Works Contracts Disputes Arbitration Tribunal act, 2008 will be applicable.
