1. Bihar Urban Infrastructure Development Corporation Limited (BUIDCo), a nodal agency for executing urban infrastructure projects in the state of Bihar, India, intends to Arrah Interception and Diversion and STP Scheme under Nammi Gange in Bihar
2. BUIDCo invites Proposals from eligible Consultants under **National Competitive Bidding (NCB)** for Preparation of Detailed Project Report for Arrah Interception and Diversion and STP Scheme under Nammi Gange.
3. Bidding will be carried out under single stage two envelope (technical and financial bid) system. Consultants will be evaluated under Least Cost Basis Selection wherein the technical proposal would be first evaluated and those proposals which meet the qualification criterion of 75% marks as laid down in RFP Document will qualify for opening and evaluation of Financial Proposal.
4. **Eligibility Criteria for participating Consultants:**
 - (i) Consultant(s) should have been incorporated and operational in India for at least 5 years as on 31st March 2022.
 - (ii) Average annual turnover of the Consultancy Firm (s) for the last five financial years ending on 31st March, 2022 should be equal to or greater than INR Three Crore.
 - (iii) Consultant(s) should have experience in preparation of DPRs for Sewerage System /I&D and STP work.

Interested Consultants may submit their proposals along with (i) Bid Document Cost of INR 10000.00 (Non-refundable) and (ii) Bid Security of INR 3 Lac (Refundable) as per provision of RFP Document on or before the Due Date and Time of **17.06.2022, 15:00 hrs.** The Bid will be opened on **18.06.2022 at 15:30 hrs.**
