PSU, Electrical contract license, affidavit regarding blacklisted & debarred from Central/ any State Government/ PSU under Central or any State Government, etc. The rate bid documents will be contain in the BOQ. in which only rate would be quoted. The technical bid will be opened & assessed first and subsequently the rate bid of technically successful tenderers shall be opened.
