1. 'Namami Gange Programme', is an Integrated Conservation Mission, approved as 'Flagship Programme' by the Union Government in June 2014 with budget outlay of Rs.20,000 Crore to accomplish the twin objectives of effective abatement of pollution, conservation and rejuvenation of National River Ganga. The National Mission for Clean Ganga (NMCG) (Department of Water Resources, River Development & Ganga Rejuvenation, Ministry of Jal Shakti, Government of India) is the funding agency for Namami Gange Programme and intends to apply a part of the said budget outlay towards payments under the contract for work detailed below.
2. Qualification requirements as listed briefly below are required to be fulfilled by the bidder. [Bidders are advised to refer to the bidding documents for complete details.]

Financial:

- a. The Bidder shall demonstrate that it possesses a net worth equivalent to minimum of INR 32.44 Cr. in each of the last three financial years preceding the date of submission of bid.
- b. The Bidder shall demonstrate by submitting along with its bid, a banker's certificate that it has available cash credit facility equivalent to minimum INR 18.54 Cr. as on the date of submission of bid

Technical:

1. The Bidder must have to attach experience certificate that It has Designed/developed, built, tested, and commissioned during last 7 years preceding the month of publication of NIT, STPs (having effluent parameters as BOD < 10 mg/l, TSS < 20 mg/l, COD < 50mg/l, TN < 10mg/l and TP < 2 mg/l) as per following criteria:

ONE STP of 30 MLD or
TWO STPs of 20 MLD or
THREE STPs of 15 MLD

2. The bidder or his nominated sub-contractor must have to attach experience certificate that it has successfully commissioned at least one Sewage Treatment Plant with the same technology as proposed for this contract (Buxar I&D and STP) by the bidder for atleast 20 MLD capacity and that

STP must be operating successfully for a period of 1 year in last 7 years preceding the month of publication of NIT.

3. The Bidder must have to attach experience certificate of Operating and Maintaining successfully of at least 1 STP of 30 MLD or 2 STPs of 20 MLD or 3 STPs of 15 MLD for 1 year in last 7 years preceding the month of publication of NIT.
 4. The treatment technology proposed for this contract has been adopted (not necessarily built by the bidder) in at least 3 locations for atleast lowest STP capacity specified in clause 1.4 (a) (1) during last 7 years preceding the month of publication of NIT and that such STP has been operating successfully (meeting the required performance standards of BOD < 10 mg/l, TSS < 20 mg/l, COD < 50mg/l, TN < 10mg/l and TP < 2 mg/l) for a period of minimum 2 years over a period of last 7 years preceding the month of publication of NIT."
 5. The Bidder must have to attach experience certificate that it has designed, developed, built, tested and commissioned Sewerage Network of 9000 Mtr length of which 1100 Mtr should be equal to or above the pipe diameter 1000 mm; and pumping station of any capacity collectively from maximum 3 projects in last 7 years preceding the month of publication of NIT.
 6. The bidder or his nominated sub-contractor must have to attach experience certificate of Operating and Maintaining Sewerage Network of 9000 Mtr length and pumping station of any capacity collectively from maximum 3 projects for 1 year in last 7 years preceding the month of publication of NIT..
 7. The bidder or his nominated sub-contractor has designed /built and commissioned pipeline using trenchless technology for minimum of 500 mtr during the last 7 years preceding the month of
